



Infant-Toddler services partnered with other local agencies to provide **17** developmental screening clinics throughout the 13-county service area.

273 children attended free developmental screening clinics.

543 children ages birth-to-5 years received



ADULT SERVICES

WORK SERVICES & EMPLOYMENT

- Sales related to production contract work for the year totaled \$62,940.
- **47%** of clients enrolled in work programs are employed full or part-time in the community.
- **89** persons were served in work programs and 42 were employed in the community.
- Employment programs reported \$235,447 in wages. Up over \$14,666 from 2021.
- Community jobs include courtesy clerk, grocery stocker, grounds keeping, janitorial, paper carrier, paper shredder, assembly, food service, and healthcare support.
- 11 of 12 new jobs created in 2022 are still active.

CASE MANAGEMENT

- **570** individuals received case management from the agency. Up 14 from 2021.
- Case Managers have an average caseload of **31** clients.
- Case Record Review scored an average of 98%.

DAY SERVICES

- 157 individuals were enrolled in day programs, which include Adult Life Skills and Retirement.
- Persons served in the Adult Life Skills and Retirement Program clocked a total of 15,718 volunteer hours in 2022.
- Individuals participated in 17,595 community activities of their choice.

RESIDENTIAL SERVICES

- 150 persons were served in residential programs.
 Of those, 118 live in agency housing.
- During 2022 the residential program continued to focus on increasing community inclusion for individuals served.
- 98% of persons living in agency housing had their own bedroom.
- We have the capacity to serve 16 additional people in residential services. Staffing shortages & state waiting list for funding are barriers.





STAFF TRAINING

CARF ACCREDITATION

The Commission of Accreditation of Rehabilitation Facilities (CARF) announced that Arrowhead West, Inc. has been accredited for a period of three years for its Children and Youth: Early Intervention Services, Community Employment Services: Employment Supports, Community Employment Services: Job Development, Community Housing, Community Integration, Services Coordination and Supported Living programs. The latest accreditation is the 15th consecutive Three-Year Accreditation that the international accrediting body, CARF, has awarded to Arrowhead West, Inc.

This accreditation decision represents the highest level of accreditation that can be awarded to an organization and shows the organization's substantial conformance to the CARF standards. An organization receiving a Three-Year Accreditation has put itself through a rigorous peer review process. It has demonstrated to a team of surveyors during an on-site visit its commitment to offering programs and services that are measurable, accountable, and of the highest quality.


